## Marana Shooting Club range safety rules.

- 1. Drugs of any kind and alcohol are strictly prohibited on the premises, as well as use prior to using the range.
- 2. Persons under 18 years using the rifle range or 21 years of age using the pistol range must be accompanied by a parent.
- 3. Bring only unloaded firearms on to the premises. Loading is performed only at your firing point. Unload your weapon and leave the slide or cylinder open before you leave your firing point.
- 4. Only standard loads of ammunition or allowed on the range. No armor piercing, steel core, tracer, or other exotic Ammo.if in doubt consult the range safety officer.
- 5. You may not use a shoulder, ankle, Cross draw or other eccentric holster on the range. Drawing and firing from a holster is prohibited less authorized by the range safety officer.
- 6. The RSO may inspect any firearm or ammunition to be used on the range. Any firearms or ammunition found to be unsafe or unserviceable will not be allowed on the range.
- 7. Anyone entering the range must have attended the range safety briefing before use.
- 8. Maximum of two persons per firing point. Spectators will not be allowed on the firing line.
- 9. Eye and ear protection is mandatory for all on the range.
- 10. Fire only at your targets, no one else's targets, no wild animals, or any other on authorized target.
- 11. Dry firing unloaded firearms is permitted from the firing point, please notify the RSO.
- 12. The command "cease-fire "means stop firing immediately, clear, safe, and bench your firearm, then await further instructions. Resume firing only at the direction of the RSO commands may be given by voice, whistle, or touch. Be attentive
- 13. If you experience any unfamiliar malfunction, stop firing immediately, place the Firestone on the bench with the muzzle pointed downrange, and request assistance from an RSO.
- 14. Leave the action open on any firearm resting on the bench.
- 15. Accidental discharges, damages, or other injuries, no matter how minor they may seem, must be reported to the range safety officer immediately.
- 16. Never move forward of the firing line to retrieve dropped objects. Request and or wait for a cease-fire from the RSO, wait for the range to be safe before moving forward of the firing line.
- 17. No eating drinking or smoking on the firing line, and exception will be made for water hydration.
- 18. Only approved targets maybe used, nothing glass or clay pigeons will be allowed.
- 19. Persons who are prohibited by state and or federal law from purchasing, possessing, or using firearms are prohibited from the use of range facilities.
- 20. Marana shooting club reserves the sole right to deny membership and/or access to range facilities to any person that the club reasonably believes such use and presence by such persons may constitute an unsafe environment.
- 21. No refunds given to persons that are removed from the range for safety reasons or damage.

- 22. The range safety officer has the final authority.
- 23. Every active firing line will have one RSO minimum and more as needed. A ratio of 5–7 shooters per RSO is generally recommended and less shooters per RSO as safety dictates.
